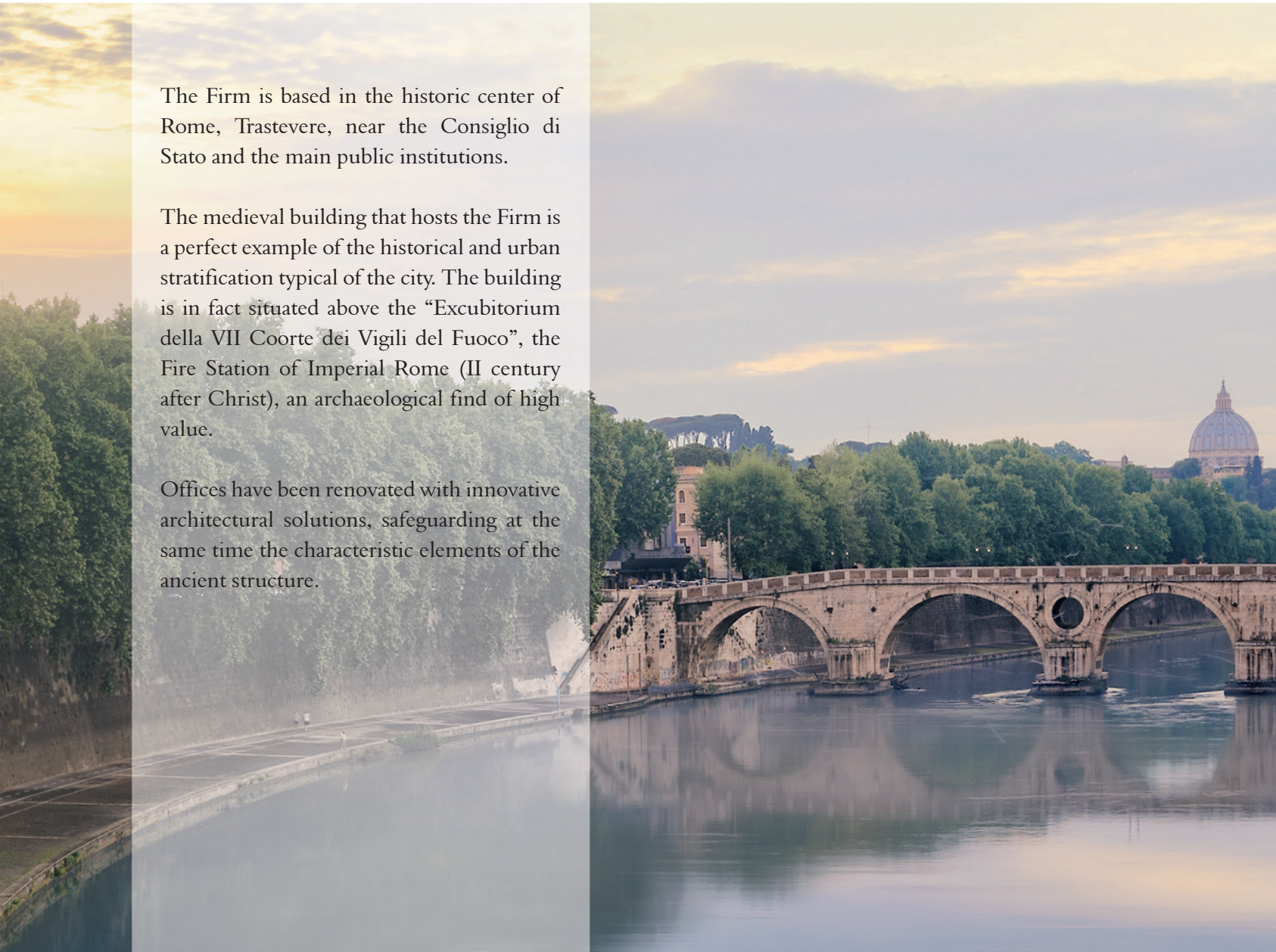




The Firm is based in the historic center of Rome, Trastevere, near the Consiglio di Stato and the main public institutions.

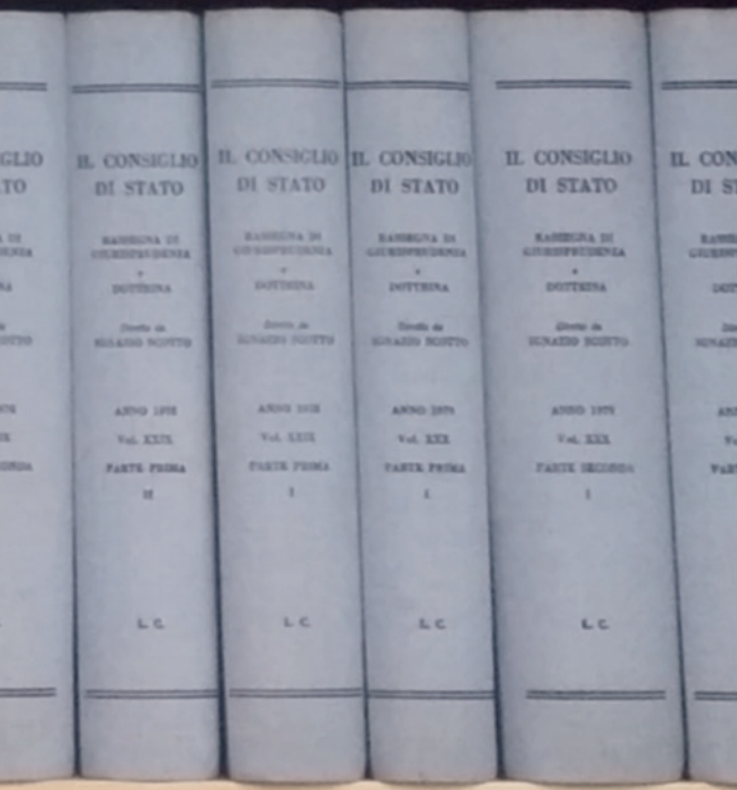
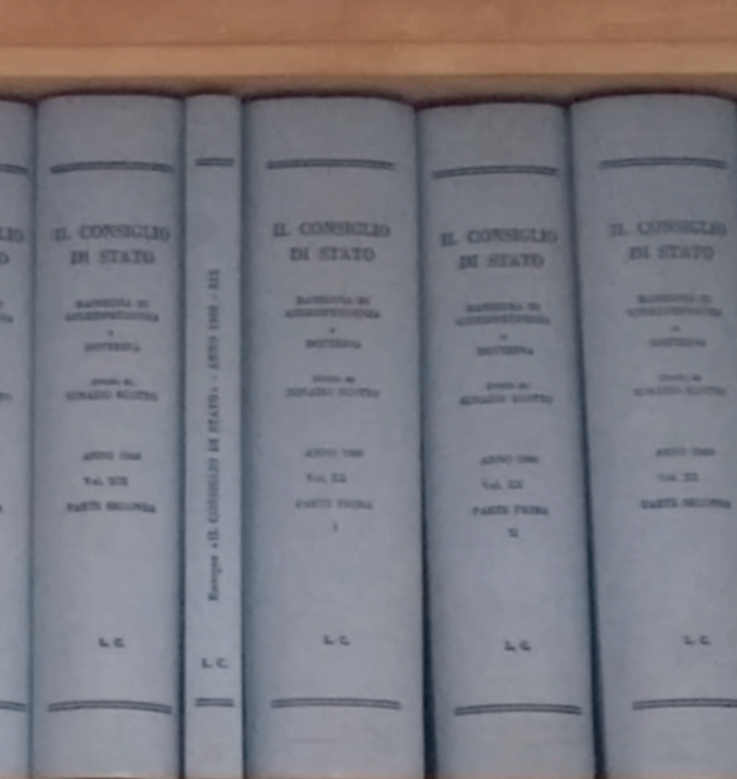

# PRACTICE AREA

The Firm assist Clients in all public administration operating areas: procedures, consulting, administrative and tax litigation. Clients receive advice that is tailored to their specific needs.

## PUBLIC CONTRACTS

Assistance is provided to contracting authorities and private operators in public works, services and supply contracts. The Firm supports Clients during the entire public tendering process aimed at awarding a contract and then during its execution. The Firm supports also Contracting authorities in identifying the tender procedures most suited to their requirements and in drawing up the *lex specialis*. Lawyers regularly represent Clients before administrative courts (TAR - regional administrative courts - and Consiglio di Stato - administrative appellate court) and before Autorità Nazionale Anticorruzione (Anac - National Anticorruption Authority).
